Proposed Schedule of 2015 Cheoah River High Flow Events

Dear Secretary Bose:

On January 25, 2005, the Federal Energy Regulatory Commission (FERC) issued a New License, effective March 1, 2005, for Project No. 2169. Section 1.2.2 of Appendix A of the License requires Brookfield Smoky Mountain Hydropower LLC (BSMH), as the licensee, to provide high flow events in the Cheoah River and to provide 12 months prior notice to FERC, the U.S. Fish and Wildlife Service (USFWS), U.S. Forest Service (USFS), North Carolina Wildlife Resources Commission (NCWRC), North Carolina Department of Environment and Natural Resources (NCDENR), Eastern Band of Cherokee Indians (EBCI), and Graham County of the proposed schedule of high flow events.

The high flow events for 2015 will follow the Year 1 schedule presented in Table OR-2.3 of Appendix A of the License, as presented below:

During that meeting, BMSH reviewed a proposed schedule for the 2014 Cheoah River high flow releases.
